

AFG: Privacy Policy

We would like to take this opportunity to welcome you to the online and mobile services that are offered by Acuna Fulgencio Group LLC ("AFG," "we," or "us") as well as the online and mobile services that are supplied by P3rson Inc. ("P3rson.com," "we," or "us"). AFG, LLC, and P3rson, Inc. are two separate legal entities that have entered into agreements with one another regarding the licensing of software, the sharing of data, the licensing of data, and the storage of data. These agreements were made possible by the fact that both companies are members of the same industry association. This Privacy Policy (the "Policy") covers the collection, use, disclosure, and sharing of information by both AFG and P3rson.com. It also addresses how we protect the information we collect.

This privacy policy was made by both P3rson.com and AFG on their own. It covers how they use data and information they get from each other, such as data they collect, keep, process, analyze, and sell. This policy also applies to their use of data and information obtained from third parties. This privacy policy is applicable to certain applications and platforms provided by AFG and P3rson.com. For example, paying subscribers, agents, scouts, influencers, and third-party providers can access the "Timeline" and "P3 packages," respectively.

Our Privacy Policy covers the many kinds of information that we gather, as well as how we capture, use, disclose, and share that information for our independent yet interdependent services and products. You have the ability to exercise control over your personal data and learn how to alert AFG and P3rson.com if you require us to modify or amend the information we hold on you. You may do this by visiting their respective websites.

P3rson.com is a mobile application that AFG maintains and hosts, and AFG is the owner of the license for the software that drives the application. You are agreeing to be bound by both the P3rson.com Terms of Service and the AFG Terms of Service when you download and use the P3rson.com app.

1. HOW WE COLLECT AND USE INFORMATION

For the purpose of conducting business, Acuna Fulgencio Group LLC ("AFG," "we," or "us") and P3rson Inc. ("P3rson.com," "we," or "us") have agreed to the terms of this privacy policy, which governs the collection, use, disclosure, sharing, and protection of any and all confidential information that you provide.

When you register for an account on either AFG or P3rson.com or communicate with either one of us, we ask for particular information that can be used for authentication reasons. This information includes your username, first and last name, birthdate, phone number, and e-mail address. We may also keep any messages you send us through our platforms, websites, apps, and services, and we may collect any information you include in User Content you send to our platforms, websites, apps, and services. This includes, but is not limited to, the following: We

utilize this information to manage our business, monitor quality, figure out what went wrong, and make sure that our services have all of the features and functions that our clients require.

You may send personally identifying information to AFG and P3rson.com if you use AFG's forms, which were developed by P3rson.com and licensed to modeling agencies, Agents, and scouts. These forms can be found on the AFG website. This contains information that can be used to identify you, such as your name, address, email address, gender, and date of birth. It also includes information about the particular physical quantities and dimensions that you possess. AFG and P3rson.com may also collect and preserve any personally identifiable information that you voluntarily supply to us in the form of images, videos, voice recordings, or other types of media. This information may include:

You are under no obligation to reveal any part of this information in any way. Nevertheless, when you provide such information, it may be made "public" and accessible to other users of AFG and P3rson.com. These users may include, but are not limited to, agents, scouts, clients, and third-party partners and vendors. Your status will determine whether or not such information is made "public." As a result, you should give the personal information that you publish in your profile a lot of thought before doing so, and you should also check to make sure that the information is true. At any time that you see fit, you can make adjustments to, make additions to, or otherwise modernize your profile.

In addition, we need you to provide us with the login information for your email account so that we may access it. By sifting through your emails in search of appointments that are relevant, we are able to provide calendaring and scheduling features for signed models. We will collect your email address and mobile telephone number in order to give you notifications if you sign up to "opt in" for any mailing list or notifications offered by AFG or P3rson.com. If you do this, we will send you information about our products and services. This information will be used, and only this information, for this purpose.

If you provide it to us in connection with any discounts or promotions made available by our third-party partners and merchants, we may additionally collect personally identifiable information from you. P3rson.com and AFG are unable to regulate the way in which other websites manage or use the information that they receive about you since we do not have access to that information. Regarding the procedure of data collection, as well as the pages of third-party suppliers and partners that can be reached by hyperlinks and are not under the control of AFG or P3rson.com, we do not make any promises or provide any assurances. It's possible that these other websites and third parties have their own privacy policies and conditions of use, and that they might be different from the ones that AFG and P3rson.com have. We strongly recommend that you take the time to read the privacy policies and terms of service of every website or program that you visit or download.

Even if it isn't specifically mentioned, the meaning of each capitalized term in this policy is the same as what it is in our Terms of Service. This includes words that begin with a capital letter. AFG and P3rson.com are each their own distinct legal entities, and the purpose of this Privacy

Policy is to shield them from any potential legal exposure they may face. In the state of New York, our Privacy Policy has the force of law behind it.

Passive information collection: AFG and P3rson.com collect non-personal information sent to us by your web browser or device, such as your domain name and user name, both directly and through agencies and scouts with whom we have contracts. This information is aggregated and is not personally identifiable.

Information received from third parties: AFG and P3rson.com may receive information about you from third parties. For example, if you access our services through a third-party connection or log-in, that third party may pass certain information about your use of its service to us. Before you link or connect third-party websites or services to the Services, you should always check and, if necessary, change your privacy settings on those sites and services. You may also unlink your third-party account from the Services by adjusting your settings on the third-party service.

Email information: After you provide AFG and P3rson.com with your email information, we will receive and analyze information about your emails from third-party email software providers. The information collected may include, but is not limited to, email addresses, subject lines, email formats, dates, names, iCal/Google Appointment/Outlook meeting request files, financial information, information about expenses, and other information related to modeling and casting. We mostly use this information to find communications between modeling agencies, make schedules and calendars, and provide and improve the services in other ways.

Cookies and other technology: When you visit our website or use our services, AFG and P3rson.com automatically get some types of information about how you use them. We use cookies and other technology to collect information about how you use the Services, including the pages you view, the links you click, how frequently you access the Services, and other actions you take on the Services, and to allow us to track your usage of the Services over time. We use or may use data collected via cookies, log files, device identifiers, location data, and clear gifs to provide custom, personalized content and information, including advertising, and to link or combine with information we get from others to help understand your needs and provide you with better service.

Location data: When you access AFG and P3rson.com from or through a mobile device, we may receive or collect and store a unique identification number associated with your device ("Device ID"), your mobile carrier's name, the type and manufacturer of your device, your phone number, and, depending on how your mobile device is set up, your geographical location data, such as GPS coordinates (e.g., latitude and/or longitude) or similar information about the location of your mobile device. We may use location information (information about the location of your device) each time you attend an event (i.e., casting, client work, an appointment with a third-party merchant or service provider, or attendance at our partners' events). We collect this information so that we can keep track of the events you attend, the castings you finish, and the jobs you do.

We use the information we get in a passive way to learn more about how people use our websites and services and to make the whole experience better for them. This includes, but is not limited to, looking at how people use the site, finding technical problems, and figuring out what went wrong and how to fix it. We may also use this information to create aggregate, non-personally identifiable information about our users that we may share with third parties for marketing, research, or other reasons.

We might also get information about you from third parties, like social media sites, if you use their connections or log-ins to get to our services. In such cases, the third party may provide certain information about your use of its service to AFG and P3rson.com, which we may use to operate and improve our own services. We encourage you to review and adjust your privacy settings on third-party websites and services before linking or connecting them to AFG and P3rson.com.

Also, if you give us your email address, we may get information about your emails from third-party email software providers and look at that information. We use this information to keep track of the events you attend, the castings and jobs you finish, and the services and products you buy from our third-party partners.

In short, we collect information about our users in a number of ways, such as passively through web browsers and other devices, through third parties, and through cookies, log files, and other technology. We use this information to run, improve, and talk directly with our users about our websites, apps, and services. We care about the privacy and security of the information about our users and do our best to protect it in line with our Privacy Policy and the laws and rules that apply.

2. HOW WE STORE AND PROTECT YOUR INFORMATION

Your information that has been gathered through AFG and/or P3rson.com may be stored and processed in the United States or in any other country where AFG, P3rson.com, and their subsidiaries, affiliates, or service providers have facilities. This may include the European Union. If you live in the European Union or another region that has laws regarding the collection and use of data that may be different from the laws of New York State, you should be aware that AFG or P3rson.com may transfer information, including personal information, to a country or

jurisdiction that does not have the same data protection laws as your jurisdiction. This is something that you should be aware of. 3. SHARING OF YOUR INFORMATION

Under certain circumstances, we may disclose your personal information to third parties. Please look at the section called "Your Options About Your Information" for more information about what you can do with the information you give.

Please be aware that by using our services, you may exchange information about yourself with other people and connect with new individuals. By default, other users of the service can see your name, photo, location, and other information that can be used to identify you. Search engines may also locate and display your information to the general public. By using the service, you agree and understand that other users can see the information in your profile as well as your current location. Before logging in to our service or giving anyone else access to your information, you should take steps to protect your privacy and ensure your safety.

Additionally, we may share or disclose your personal information with the following parties:

- Third parties who we believe may offer you products or services may enjoy participating in partner promotions. AFG or P3rson.com may collaborate with third-party partners on contests, sweepstakes, or other types of promotions. If you participate in a promotion, contest, or sweepstakes that is run by a third-party partner, the information you submit will be shared not only with us but also with them. The use of your information by third parties is not governed by this privacy policy in any way.

- The general public as well as other members or users of the services provided by AFG and P3rson.com may access your information upon request. Any information or content that you voluntarily upload to AFG and P3rson.com Services, such as User Content, becomes available to the public, subject to any applicable privacy settings. Adjust your profile settings to change the privacy options available to you on the AFG and P3rson.com websites and mobile apps. Any user content you make public is searchable by other users and can be used according to the terms of the AFG API, provided that your profile and privacy settings allow it. Any party that makes use of the AFG API is subject to the API Conditions of Use, which include the provisions of this privacy policy as an integral part. If you delete data from the service, it is possible that copies of such data will still be accessible through the cached and archived pages of the service or if other users have copied or stored that data. other members or users of the AFG and P3rson.com websites and applications, to increase your chances of being "discovered" on those websites and apps. - AFG and/or P3rson.com are not responsible for the privacy practices of third-party websites or services that may be linked to or from our websites and mobile apps. Before providing any personal information to a third party, you should read and understand their privacy policies and practices.

AFG and/or P3rson.com shall not be held liable for any loss or damage arising from the disclosure of your personal information to third parties in accordance with this policy. By using our services, you acknowledge and agree to the sharing and disclosure of your personal information as outlined in this policy.

- Social media applications: Some AFG websites, P3rson.com apps, and/or other websites and apps licensed or developed by P3rson.com and/or AFG may have social media-sharing features and functions, as well as other integrated tools (like the Facebook "Like" button) that let you share what you do on our Services with other media and vice versa. For instance, you can post a status update on Facebook from within the P3rson.com app. When you use these features, you have the option of sharing information with either your friends or the general public. AFG and P3rson.com will use the personal information that is collected from or about you for the purpose of business and marketing communication with you. You agree that AFG and P3rson.com are privately owned businesses that do not do data processing work for the government or any organization connected to the government. At this time, we only serve a small percentage of the entire population and number of users overall. We are keeping track of our responsibilities under GDPR, and as our services and platforms continue to expand and/or change, we will update our policies.

AFG and P3rson.com do not treat users from the EU, EEA, or UK any differently when those users exercise any of the rights that are outlined in this privacy policy. Be aware, though, that if you don't want us to use your personal information, we might not be able to share it with AFG and P3rson.com agents, scouts, agencies, clients, or vendors. If this is the case, we ask that you please be mindful of this fact.

7. Consent to Transfer Information to the United States

If you live outside of the United States, you should know that any personal information you give to AFG and P3rson.com, including information we collect about you, will be sent to, processed in, and stored in the United States, no matter where you live now. The data protection laws in the United States may be different from those in your country of residence. As a result, the government, courts, or law enforcement agencies in the United States may have the right to access your personal information. By giving AFG and P3rson.com your personal information, you agree that it can be sent to the United States to be processed, stored, and used to provide services, as well as to show your personal information to third-party partners and vendors. You agree that modeling agencies that use AFG and P3rson.com follow standard operating procedures in the fashion and modeling industries. This includes putting pictures of their models on their websites that have already been printed or posted online. By using AFG or P3rson.com's websites, apps, databases, or platforms, you agree that third parties can use these photos however they like. If you are a model, photographer, publisher, or any other person who owns the rights to a picture being used by an "unbranded" app managed or hosted by AFG or P3rson.com and you have concerns about how your images are being used, please contact the agency that is responsible. You understand and agree that AFG and P3rson.com will not be held responsible for any damages or violations that may happen because third parties are using your images, and you release us from any liability in this regard. You also agree to protect AFG and P3rson.com from any claims, losses, expenses, or liabilities that may come from the wrong use of your images. You also agree to take legal action against any agency that uses these publicly available fashion images without permission while using our website, apps, databases, or platforms.

9. "DO NOT TRACK"

At the moment, neither AFG nor P3rson.com can respond to "Do Not Track" signals that your browser may send. However, we do our best to respect our customers' privacy preferences. As previously mentioned, we utilize cookies to track user behavior on our website. Please note that we do not give any guarantees or assurances about the data collection practices or pages of partners, scouts, third-party vendors, or other agents whose websites may be linked to by AFG or P3rson.com, but we do not own those websites. Our data collection process via cookies will not be affected by the "Do Not Track" signals.

10. Children's Privacy

The Children's Online Privacy Protection Act (COPPA) is important to AFG and P3rson.com, so we don't let kids under 13 use our products or services. We don't collect personal information from children under the age of thirteen, nor do we ask them for it. Our products, services, and content are not made for or aimed at children under 13 years old, nor are they made for them. Neither AFG nor P3rson.com violate the Children's Online Privacy Protection Act (COPPA). Because of this, we do not let people younger than 13 use our products and services. We do not

collect or request personal information from children under the age of 13, and we do not collect or request this information from children under the age of 13. Our products, services, and content were not made or meant for children under 13 years old, and they are not available to them. We do not target either of these demographics.
